#### **Project Pipeline**

Terms of Reference stipulate that the Contractor must identify a project pipeline of at least 200 projects that could be taken forward by the successor Phase 2 projects. Work was undertaken in this area especially by the 6 local experts in each NUTS region, by STE (local) assistance) to support project mapping, review and delivery of modular assistance, under the management of Colm McClements (Pipeline Manager). Over 90% of the inputs were therefore Bulgarian.

We have met this objective through following results:

- <u>First Wave</u>: 201 projects assisted through modular assistance worth , now ready for TA assistance to complete elaboration and finalization stages
- Second Wave: 44 additional projects worth assisted but not yet so advanced. 398 projects (originally
  part of batch assessed as relevant, feasible and ready within 18 months) never assisted by us. Waiting
  for TA

#### Additionally we have:

- built project development capacity 341 persons assisted modular assistance, almost 100% satisfaction rate for all trainings and workshops
- built capacity of around 45 MRDPW officials a) to enroll, screen, review projects and b) to assist
  projects through information, communication and coaching almost 100% satisfaction rate for all
  trainings and workshops for this group
- developed/perfected an original project idea review and assessment methodology and a project development methodology – persons are trained in their application
- contributed to targeting, concentration, implementation modalities of operations by drawing out lessons
  of project promoters, their projects and capacity (April 2007) the Team carried out a detailed analysis
  on potential absorption against priority and operation and proposed very detailed and carefully crafted
  changes to operations to ensure appropriate demand. This very substantial work is elaborated in the
  Report¹ delivered to MRDPW on 10th April 2007

With respect to the project pipeline the outputs of the comprehensive project mapping exercise led to organization of direct assistance to projects as follows:

- Around 1500 projects registered and assessed
- 619 (624 Mio EUR) considered relevant, feasible and ready in 18 months
- 460 (of 619) considered relevant, feasible and ready in 12 months, submitted to MRDPW
- List of Projects after amendment by MRDPW 408 projects (around 90 added by MRDPW, around 140 eliminated/merged)
- Of 408, 327 judged appropriate for modular assistance
- Of 327 offered assistance, 297 projects (and 341 promoters accepted assistance)

We simply exclude them from our and further pipeline assistance, on the grounds that the promoter shows no motivation to participation in any such (freely given, tax-payer derived) support, and as a matter of principle, we do not give them a second chance. The MRDPW may decide differently later.

#### **Modular Assistance:**

In June 2007 a modular programme of 2 x 2-day modules was designed to support the 231 projects and their promoters. This was agreed with the MRDPW and undertaken through 19 courses by a team of PDOs and STEs.

As a result of this the following results can be reported:

 201 projects are now considered to be viable as ideas: this means that according to our methodology, they have completed conceptualisation and design stages and can now be more technically elaborated an finalized.

The cycle of workshops has been extensively evaluated. Almost all participants have filled out written feedback forms for each of the workshops. The professionalism of the facilitators, quality of materials and relevance of the workshops have been extremely highly evaluated with scores as below:

The cycle was based on our 4-stage methodology to project support according to which a project is considered to have advanced to the requirements of successor TA Phare support if:

- Its design no longer involves any major internal obstacles that could adversely affect its development: therefore it is justifiable to afford it more intensive TA relating to inter alia, technical design, economic and financial testing, full and detailed elaboration of all activities, costs, budget etc. Statistically this has been set at a scoring of 2.5.
- Stage 1: Conceptualisation
- Stage 2: Design
- Stage 3: Elaboration
- Stage 4: Finalisation

#### Handover to Phase 2

In addition to advancing the project ideas and ensuring their viability, we have produced a short diagnostic report on the current situation with each project and on the required next steps, including necessary technical assistance in order to complete them. This has been a relatively demanding exercise. We leave for the follow up contractor our own professional assessment of what now should be done and how, and the perception of the application on the current situation with his project and on next steps. In fact in most cases, due to our shared approach, there is little divergence between the two.

This means that the successor contractor does not need to "assess" these projects further. He merely needs to read the documentation, contact the applicants and devise a suitable manner in which to deliver assistance. In our view this work can start almost immediately and should not be deferred until the successor project reaches its own implementation stage. The fact is that the promoters are now extremely enthusiastic and committed and are continuing to work on their projects. They want technical assistance urgently.

The Contractor has delivered promised results in this area. Unfortunately it is our view that we could have gone well beyond the ToR requirements: however delays in approving the list clearly led to a loss of time, momentum and expectation among project applicants. Moreover a very large number of the projects proposed by the MRDPW and never assessed by us proved to be neither relevant nor feasible and have not progressed as quickly as others. This lowers the overall result.

With regard to the next steps we identify the following issues and make the following recommendations:

1. The successor project will have a budget in excess of 4MEURO, nearly twice that of the current project. It will focus on one OP only (not 3) and on one key task only – project development. In our view there are more than enough resources to bring rapidly to completion the entire pipeline we have now identified as fully viable.

We recommend that all 201 projects be assisted by the successor contractor immediately on starting his project and that all of them completed by end June 2008 at latest, and many of them much earlier. This, we call, the "<u>first wave".</u> This goes significantly beyond the (in our view somewhat modest) requirements of the ToR.

2. We consider that there will exist ample resources to work on other projects as well. We note that we originally assessed 650 as relevant, feasible and ready within 18 months. No more than around 180 of these were ever assisted directly by us (since in out 231 there existed a number of projects proposed the MRDPW). Therefore there currently exist 432 projects that constitute a "second wave" of already assessed projects (44 of them are not so advanced but did receive modular assistance: the remaining 398 never received any direct assistance of any kind.) . This is the logical starting point for the successor contractor to tap into an extended pipeline. Some of them will now no longer be relevant since the OP has changed or applicant has given up. Some may have advanced without our assistance. Not to use these would be a serious waste of effort and public money!

We recommend that the successor contractor contact all of the above mentioned promoters to ascertain the situation of their project and whether or not they wish assistance. If they do so wish, we recommend that a modular approach be adopted in order to take them rapidly through the stages of conceptualisation and design. After this they can also be helped in terms of technical design subject to availability of resources.

3. We encountered the difficulty in ourwork that in the view of the MRDPW our list did not adequately reflect geographical distribution. We recognize that this can be a legitimate concern. However if so it would need to have been specified as a parameter from the outset: the MRDPW never requested this and made no


requirement at any stage in this regard. A similar Czech project in 2004 did in fact make such a requirement in its Terms of Reference.

We can envisage that this may still be an issue.

We therefore recommend that If so it can be most simply addressed by offering to all municipalities who have not received any form of project assistance from the other two sources mentioned above, a special assistance – on condition that they a) identify an initial project idea and b) agree to attend a modular programme whose objective is to work up their projects. This may be seen as a "catch up " class, assisted in order to ensure that all municipalities can have a realistic chance of benefiting form the ROP. In our view municipalities should be admitted to this irrespective of the quality oif their project idea (hence no prior assessment) but it is important that they do indicate their seriousness by defining a project idea and by registering for the assistance. In our view the resources of the successor project are ample to allow for this work as well.

#### In this manner, on the basis of our work, it is possible for the successor project to:

- Bring 201 projects to completion and submission before end June 2008 at latest
- To bring at least 50% of the 400 identified to a stage of project idea viability ie around end of Stage 2 and at a further 100 well into Stages 3, 4 of further by end October 2008
- To develop a number of other project ideas from weaker municipalities (a new "third wave").

It is obviously necessary for the MRDPW to use Priority 5 of the OPRD to ensure on-going support in a 3<sup>rd</sup> later project. Under this logic each significant consultancy input of around 12 months could a) complete one wave of project and b) develop and promote the emergence of the next wave. If this could be achieved then there would realistically be few problems of absorption – at least in terms of a supply of good projects – within the OPRD.
